Advocacy Mandate

LTC Commission Interim Report Oct 23, 2020 Music to Our Ears

- Appropriate staff mix
- More full-time positions
- Comprehensive human resources strategy (The ministry's Long-Term Care Staffing Study, released in July 2020, identifies the best path).
 Further "study" of the Study is not necessary. What is required is the Study's timely implementation
- Minimum daily average of four hours of direct care per resident
- Families and caregivers have ongoing, safe and managed access



TIME TO CARE ACT



- Passed Second Reading by all parties Oct 29th
- Sent to Standing Committee on Social Policy
 - Study (seriously we need more ?)
 - Agree on wording of the Bill
 - Assign money
 - Committee members support priority items
- Keep in touch with MPPs need to expedite to Third Reading

A senior government source not authorized to speak publicly says the province will announce its commitment to the standard today, with a pledge to have it achieved by 2024-2025.
